

Replacement of Deck and Kickboard for Platpole Platform

GENERAL INFORMATION

PLATPOLE DECK AND KICKBOARD REPLACEMENT PROCEDURE

- 1. Place the Platpole on a bench to undertake the replacement of the deck and the kickboard.
- 2. Undo the M6 nuts securing the kickboard to the platform. If the screw is turning then you will need to remove the nonslip tread to access the Philips headed screw so you can undo the nylok nuts.
- 3. Remove the kickboard.
- 4. Repeat the Step 2 above for the M6 nuts holding the deck to the metal frame.
- 5. Remove the deck.
- 6. Place the new deck upside down with the SWL facing up and invert the Platpole and centre it on the deck ensuring it is central and hard up against the kick pad area. Mark the holes as the deck needs to be drilled prior to securing it to the platform. Drill all holes with 6.5mm drill and countersink on upper side so the countersunk screws are flush with the top of the board.
- 7. Once all drilled and countersunk secure the deck with the M6 Countersunk Stainless Screws, Stainless Steel Washer and M6 Nylok Nut. Once screws inserted apply some anti seize grease to prevent the stainless-steel bolts and nuts from galling. All screws must be inserted and tightened to secure the deck to the Platpole frame.
- 8. Once the deck is secure apply Selleys Kwik Grip Vertical Gel Contact Adhesive to the top of the deck and also the underside of the non-slip tread. Ensuring that the glue goes right to the edges is critical for the bonding of the tread to the timber deck and the longevity of the tread adherence to the timber deck.
- 9. Once the glue on both surfaces is tacky then place the tread onto the timber deck with roughly 2mm in from the left, right and rear edges. Gently tap over the whole surface with a soft hammer to ensure the tread adheres to the timber deck. Turn the platform upside so the tread is on the bench top and leave for the glue to harden. Generally overnight.
- 10. Place the kick board in position and repeat the marking, drilling and countersinking of the holes. Screw the wooden kick board in position and repeat the gluing process for the non-slip piece to the timber kick board.
- 11. Once the glue has dried and you are happy with the adhesion of the non-slip to the timber deck then check the chain, the welds for cracking and the pole spikes for wear / damage and if any part is damaged then they need to be replaced prior to use.
- 12. If all the checks are correct then, return the Platpole to service.
